3. **National Competitive Bidding (NCB)** will be conducted in accordance with ADB's <u>Single-Stage:</u> <u>One-Envelope</u> Bidding Procedure through electronic Government Procurement (e-GP) system and is open to all Bidders from eligible source countries of ADB as described in the Bidding Documents.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

<u>Specific Similar Experience:</u> at least 1 (one) number of contract of similar nature, complexity and methods/construction technology successfully completed within the last 5 (five) years, with a value of **BDT 205,000,000**.

<u>Average Annual Construction Turnover:</u> The required average annual construction turnover shall be greater than **BDT 510,000,000** over the last 5 (Five) years.

<u>Liquid Assets or Credit Facilities:</u> The minimum amount of liquid assets or working capital or credit facilities of the Bidder shall be **BDT 65,000,000**.

The complete qualification criteria are described in the Biding Documents.

- 5. This is an online bidding where only e-Tender (e-bid) will be accepted in the Bangladesh National e-GP System Portal and no offline/hard copies will be accepted.
